I would assume her brother Tom, as he was (and is) her only living relative.

Additionally, I understand the rights to future royalties from her back catalogue were sold to a publishing or insurance company...does that include the copyrights to her songs, as well as the actual songs themselves? I know Atlantic Records seems to hold all the rights to the DIM and ABNM albums, as songs from those two albums are few and far between on compilations, save for SOAPM. Who holds the rights to It Begins Again and Living Without Your Love as United Artists (for whom the albums were recorded) folded in the 80s? Did the rights to those two albums, White Heat, Cameo and Longing get absorbed by Universal Music, rather than remaining with her estate?

Anyone who has any thoughts or definitive answers, by all means...post away. I'm curious about aspects of Miss Dusty's life and career such as this. Call me odd if ya want to
